



## **LANXESS Competition "Concrete Sample Box"**

### **Conditions for participation**

By entering the competition, users accept these conditions of participation. The competition's organizer is LANXESS Deutschland GmbH (hereinafter referred to as "LANXESS"). The competition is not supported by LinkedIn and is in no way connected to LinkedIn.

#### **1. Eligibility requirements**

Participation in the competition is free of charge. The competition is open to architects and developers. In order to take part in the competition, participants must share the relevant post on the online portal LinkedIn at least once until December 6. There shall be no legal recourse. LANXESS employees are not allowed to take part in the competition.

#### **2. Prize and selection procedure**

LANXESS will draw 20 concrete sample boxes. The winners will be drawn and notified that they have won through their LinkedIn account. No change to the prize or payment of cash in lieu of it is possible. If the winner does not respond to the notification within 1 week, the prize shall be forfeited without replacement. The prize shall be sent by post. If a winner withdraws from the competition or cannot be reached under the data they have provided, the organizer shall appoint another winner. If a prize cannot be delivered, LANXESS shall not be obliged to make further inquiries on how to deliver it. In such a case, the winner's entitlement to the prize shall be forfeited.

#### **4. Liability**

Claims for damages against LANXESS in connection with the competition shall be excluded – regardless of the legal grounds – within the bounds permissible under the law, unless LANXESS has violated statutory obligations through intent or gross negligence. Moreover, LANXESS shall not be liable for damage resulting from impairment to the availability of the competition's Internet site in the event of technical disruptions that cannot be influenced and incidents of force majeure, as well as attacks by third parties on the competition's Internet site. However, LANXESS will undertake every effort to ensure the reliability and working order of the competition's Internet site. LANXESS also does not warrant that the competition's Internet site can work properly on the participant's computer system.

#### **5. Data protection**

As part of the competition, LANXESS shall ensure that the highest possible standard of data protection is upheld and shall comply with all relevant statutory regulations. LANXESS shall not disclose any personal data to third parties or sell address data. LANXESS shall store the personal data of participants solely for the purpose of the competition. Participants hereby explicitly declare their consent to their personal data being stored and used for the above purpose.

#### **6. Severability clause**

If a provision in these conditions for participation is or becomes invalid or there is a gap in them, the remaining provisions shall not be affected or impaired thereby. Invalid or missing provisions will be replaced by a provision that most closely approximates the purpose of the agreement and the statutory regulations.

#### **7. Place of jurisdiction / applicable law**

German law alone shall apply in the event of disputes. Any disputes shall be settled before a competent court of law in Cologne, Germany, where permissible under the law. If the participant has no general place of jurisdiction in Germany or moves their place of residence abroad after participating in the competition, any disputes shall be likewise settled before a competent court of law in Cologne, Germany.
